Description of the Defect : According to the recall 24E105 filed by InVision: "The center internal aluminum burner tube connecting the gas valve to the cook top burners can be fractured."

FMVSS 1 : NR

Description of the Safety Risk : According to the recall 24E105 filed by InVision: "If the burner tube is fractured, it could leak propane when the top burner gas valve is opened to use the appliance. If ignited the propane could result in a fire and/or explosion which could result in personal injury." Forest River recommends not using the cooktop until the remedy can be performed.

Description of the Cause : Unknown

Identification of Any Warning that can Occur : An owner may notice the odor of LP gas and/or the LP gas detector may alarm.
