October 15, 2024 – A wheel attachment concern was identified during the wheel fastening process on Subaru's vehicle production line. Subaru inspected the wheels and found that the lug seats were incorrectly specified. Subaru initiated an investigation with the supplier. The supplier determined that some wheels had been manufactured with an incorrectly specified lug seat surface.

October 15, 2024 to December 24, 2024 – Subaru confirmed that the incorrect specifications do not meet Subaru's internal safety standards. Subaru also determined the potentially affected vehicle population.

January 16, 2025 – Out of an abundance of caution, Subaru decided to conduct a voluntary safety recall campaign.

Subaru is not aware of any warranty claims or technical reports related to this condition.
