Chronology :

On November 13, 2024, VW recalled vehicles outside of the United States to replace affected head curtain airbags manufactured in a specific production lot following a field report. JSS continued its investigation into the issue and thereafter concluded that parts from the entire inflator production run may be affected. Subsequently, JSS was informed that one vehicle with a potentially affected part may be in the United States. On February 13, 2025, JSS's Product Safety Committee decided to file this report based on the information provided by VW.

Description of Remedy :

Description of Remedy Program : JSS intends to supply replacement airbag modules to the vehicle manufacturer. Please consult the vehicle manufacturer for additional information about the planned remedy.

How Remedy Component Differs from Recalled Component : Replacement airbag modules supplied by JSS incorporate inflators manufactured outside of the recalled production run.
