monitor to the bus interior ceiling may fail, causing the monitor to detach from its location. As a result, GILLIG has decided to voluntarily initiate a safety recall

campaign of the vehicle population that may be affected by the issue.

Chronology:

07/10/2024 GILLIG received formal communication from a customer of failed monitor fasteners on a vehicle causing partial detach of the equipment from the ceiling. Initial inspection indicated an improper installation of the fastening nut. GILLIG inspected the fleet and initially closed the case.

12/2/2024 A second failure was reported on a vehicle where the ceiling monitor was reported as totally unfastened from the ceiling. The inspection found the rivet-nut fasteners did not have adequate installation depth to hold the monitor attached to the ceiling. GILLIG engineering recommended a different part number to be used in lieu of the original.

02/05/2025 GILLIG completed population analysis and identified 91 vehicles potentially affected by the issue. 02/06/2025 GILLIG's Safety Committee decided to file a formal Safety recall with NHTSA.

Amended on 2/25/2025: GILLIG received a total of two reports from one customer related to this issue.

The first report was received on 7/10/2024 in form of an email and related to vehicle serial# 200281 where a loose

monitor mount was observed, due to rivet-nut fasteners installed incorrectly. The customer performed repairs no

warranty claim was filed. Customer performed inspection of the rest of fleet (14 units total) all units passed inspection.

The second report was received on 12/2/2024 from the same customer, related to vehicle serial # 200277 that had the

monitor become detached from ceiling. No injury reports, nor warranty claims and no other information from other

customers related to this issue were received.

Description of Remedy:

Description of Remedy Program: All vehicle owners involved will be notified of the recall and all affected

vehicles will be corrected at no cost to the customer. All vehicles recalled will be equipped with a different rivet-nut fastener part number which will deliver the required installation depth. Pursuant to 49 CFR 577.11(e),

Gillig requests to be exempted from providing a pre-notification reimbursement plan. Pre-notification product failures would have been

addressed under the terms of Gillig's warranty.
