Chronology :

- On February 13, 2025, Forest River's Office of Corporate Compliance ("OCC") was notified of an audit that the chassis supplier had conducted on or around February 10, 2025, in which the chassis audit revealed the GVWR printed on the FED Tag was greater than the capacity of the safety chains. OCC opened a research item into the concern the same day.
- On February 14, 2025, OCC identified additional models with the same error.
- On February 21, 2025, Forest Rivers Corporate Committee voted to recall.

## Description of Remedy :

**Description of Remedy Program :** Forest River will provide all parts and labor free of charge to Consumers and Dealers. A replacement Federal Placard will be sent to all consumers and Dealers with instructions on how to apply the replacement Federal Placard.

**Identify How/When Recall Condition was Corrected in Production :** Vehicles in manufacturing had their safety chains changed from a 7,600 lbs. rated safety chains to 11,700 lbs. safety chains during the week of February 17, 2025. Vehicles in commerce, will be issued a replacement FED Tag to derate the vehicle at or under 7,600 lbs.

## Recall Schedule :

**Description of Recall Schedule :** Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
