On February 13, 2025, Forest River's Office of Corporate Compliance ("OCC") was notified by the manufacturing plant that they received a notice from a state inspector, which indicated that a transit bus had egress handles were not visible from the aisle. OCC opened a research item into the concern.

On February 14, 2025, OCC and the plant began to identify the involved vehicles.

On February 21, 2025, Forest Rivers Corporate Safety Committee voted to recall.

Description of Remedy:

Description of Remedy Program: Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy to replace the existing bottom handle windows with side handle windows.
