Description of Defect :

Description of the Defect : The sofa footrest switch does not have a stop limit application and was manufactured with underrated wires for the application. If the switch is depressed for extended periods of time, the wires could heat up.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : If the switch is depressed for an extended period of time, that would cause the wires to heat up, it may cause a fire, increasing the risk of personal injury and/or property damage. Airstream is unaware of any property damage, or injuries related to this condition.

Description of the Cause : Underrated wires and the lack of a stop limit device combined with the switch being depressed for an extended period of time.

Identification of Any Warning that can Occur : A burning smell may occur.

Chronology :

1/22/2025 - We were notified of a Classic travel trailer with a thermal event relating to the sofa switch. We requested that the trailer be brought back to Airstream for review.

2/12/2025 - Upon the unit's arrival, Airstream started the investigation with an inspection.

2/14/2025 - We began identifying a remedy for the affected and future production units.

2/18/2025 - Ran query of historical data to determine if other occurrences related to this scenario.

2/19/2025 - We met with Midwest, informed them of the event, and discussed a potential solution.

2/25/2025 - Established the recall population.

2/26/2025 - The safety committee reviewed all known data and determined a recall is warranted. No warranty claims, customer complaints, or injuries have been related to this issue.

2/27/2025 - Airstream implemented the repair process in production.

Description of Remedy :

Description of Remedy Program : Dealers will be instructed to install the reverse relay on the sofa switch assembly of the affected units. This will be completed at no cost to the customer. Reimbursement will follow the general reimbursement policy that is on file with NHTSA.

How Remedy Component Differs from Recalled Component :	Airstream Classic units manufactured after February 26, 2025.
Identify How/When Recall Condition was Corrected in Production :	The condition was corrected when production implemented the reverse relay into the sofa switch assembly on 2/27/2025.
