Description of the Defect : • This is a bracket that is used on the side of an RV that has a receiver for

a removable step assembly to clip into. This receiver is installed using a thread locking fluid to retain the assembly. It was found that there are parts that did

not have this thread locking compound installed during assembly.

Description of the Safety Risk : • If this receiver becomes loose while being used, it can disengage from

the fastener that is used to assemble it to the bracket and disconnect from the bracket allowing the step assembly to fall from its use location. This has the potential to cause personal injury if the step is being used when this happens.

Description of the Cause: Failure to use thread locking fluid during assembly process.

Identification of Any Warning The receiver on the bracket can be spun which can cause it to unscrew and

# **Chronology:**

- 4/3/25: Alerted to a potential injury when step became disconnected on a unit in a dealer's lot.
- 4/4/25-4/10/25: We investigated what happened internally, auditing our inventory and uninstalled inventory at local OEM customers, to find the root cause of the issue.
- 4/8/25: Safety Committee met and agreed to issue a recall.
- 4/4/25-4/11/25: We pulled all inventory internally and at local OEM customers to inspect and rework as needed to make sure product was good.

#### **Description of Remedy:**

- For immediate issues, we have designed a new bracket that can be installed on units that have these parts. We are still investigating alternative methods to remedy this issue for units that are in the field and will amend this as we have alternative solutions.
- \* MORryde will be paying for 100% of this recall campaign, either directly to dealers and owners, or through our OEM customers.

To correct this issue we have conducted employee training and was Corrected in Production: added inspections to the process to ensure this will not happen again. We are also looking into alternative ways to assemble this product that will assist in avoiding a situation like this, i.e. patched bolts with the thread locking solution already on them, or different style fastening that will not require the thread locking solution.
