Description of the Defect :	Certain Entegra Coach units on the Freightliner custom chassis have a rear cap support bracket that may make contact with the OEM Engine fuel filter housing, which could damage the fuel filter housing.

Description of the Safety Risk :	A damaged fuel filter housing could result in a fuel leak. A fuel leak in the presence of an ignition source increases the risk of a fire.
Description of the Cause :	Engineering design error

2/10/2025 The Warranty Incident Review Committee (WIRC) discussed the incident and elevated it to CPAC.
2/12/25 Jayco engineering began evaluating a redesigned mounting plate, which allows the rear cap support bracket to be relocated away from the OEM engine fuel filter housing and installed it on all units in production.
3/19/2025 The Corrective Preventive Action Committee (CPAC) discussed the incident and elevated it to SSC regarding units in the field.

4/7/2025 The Safety Steering Committee (SSC) met and voted to proceed with filing a safety recall with

Jayco Inc. is aware of 1 claim where the rear cap support bracket made contact with the OEM Engine fuel filter housing.

#### **Description of Remedy :**

Description of Remedy Program :	Jayco Inc. dealers will install a new mounting plate, which allows the rear cap support bracket to be relocated away from the OEM engine fuel filter housing. Repairs made prior to the recall will be reimbursed in accordance with our Recall Reimbursement Plan on file with NHTSA. This repair will be performed at no charge. Jayco Inc. will file completion reports.
	The remedied component will have the newly designed mounting plate which allows the rear cap support bracket to be mounted away from the OEM engine fuel filter housing.
	All units onsite and current production units as of 2-12-25 have been remedied with the newly designed mounting plate which allows the rear cap support bracket to be relocated away from the OEM engine fuel filter housing.
