The suspect period began on March 8, 2018, when the first suspect vehicle was produced, and ended on February 5, 2024, when a new DAB squib connector was released for vehicle production. Vehicle production and engineering change records

were used to determine the suspect period.

Similar 2019-2022 MY vehicles not included in this recall were built with properly

Chronology:

On July 18, 2024, the FCA US LLC ("FCA US") Technical Safety and Regulatory Compliance ("TSRC") organization opened an investigation into some 2019 - 2024 MY Ram 1500 trucks for a potential issue related to the Drivers Air Bag ("DAB").

From July 2024, through April 2025, FCA US TSRC met with FCA US engineering and manufacturing to review the issue, understand the failure mode, review customer records and to determine the suspect population.

On April 9, 2025, FCA US TSRC organization recognized that a vehicle build issue existed on certain vehicles related to improper securement of the connector for the DAB, potentially resulting in a noncompliance with FMVSS No. 208.

On May 01, 2025, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

Description of Remedy:

Description of Remedy Program: All vehicles in this recall have been remedied by properly securing the

Drivers Airbag squib connector. Warranty records show these repairs

occurred between May 18, 2018, and December 27, 2024.

FCA US submitted its General Reimbursement Plan relating to reimbursement to owners and purchasers for costs incurred for remedies

in advance of the manufacturer's notification of safety-related defects and noncompliance with Federal motor vehicle safety standards in October 2024. Owners and purchasers may be eligible for reimbursement in

accordance with that plan.

How Remedy Component Differs This recall is not related to a part defect but rather a vehicle assembly from Recalled Component: issue where the DAB squib connectors may not be properly secured. The remedy will be to inspect, and if necessary, properly secure the DAB squib

connectors.
