The recall population includes certain Model Year ("MY") 2026 Model Y vehicles manufactured at the Fremont Factory between April 15, 2025, to April 20, 2025, that may have been equipped with parts from a batch of wiper arm washer hose elbow connectors that may not be compliant with FMVSS No. 104, Windshield wiping and washing systems.

### **Defect / Noncompliance Description**

On affected vehicles, one or both windshield washer nozzles may be blocked due to a defect in a washer hose connector introduced during the supplier manufacturing process, which does not comply with FMVSS No. 104 S4.2.2, Windshield wiping and washing systems.

### Chronology

- On April 18, 2025, Tesla identified certain windshield wiper arms with potentially defective hose elbows during a vehicle drive test in factory.
- From April 21, 2025, to April 25, 2025, Tesla inspected factory-gated vehicles and began investigating the scope and effect of the concern.
- During this period, based on discussions with Tesla's supplier, Tesla learned that on January 19, 2025, the supplier failed to revalidate their tooling after performing a repair, causing the defect in the suspect components. The supplier corrected the tooling error on April 17, 2025.
- From April 28, 2025, to May 1, 2025, Tesla performed physical validation and testing to determine washer system capabilities with one functioning washer nozzle.
- On May 21, 2025, having completed its investigation, Tesla found that a non-compliance exists and made a determination to voluntarily recall the affected vehicles.

• As of May 23, 2025, Tesla has identified 0 warranty claims and 0 field reports that may be related to the condition. Tesla is not aware of any collisions, fatalities or injuries that are or may be related to the condition.

At no charge to the customer, Tesla will inspect the wiper arm washer hose elbow connectors on all affected vehicles and, if necessary, replace any defective component with a wiper arm elbow connector that does not contain the defect.
Tesla does not plan to include a statement in the Part 577 owner notification about pre-notice reimbursement to owners since all of the involved vehicles remain covered under the new vehicle warranty.
How remedy component differs from recalled component:
The recalled component may have been manufactured with a blocked wiper arm washer hose elbow connector. The replacement component does not contain the defect described above.
Identify how/when recall condition was corrected in production:
Beginning on April 20, 2025, vehicles in production received a wiper arm washer hose elbow connector that does not contain the defect described above.
