Defect / Noncompliance Description

Description of the defect or noncompliance:

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has determined that on certain Model Year ("MY") 2023 GLC (254 platform) vehicles, the retaining cap covering the headlamp horizontal aiming screws might not have been installed during vehicle production.

FMVSS1: 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS2:

Description of the safety risk, including crash, fire, death, injury:

In this case, the headlamps are able to be adjusted horizontally, which is not intended. Subsequently, the regulatory requirements of FMVSS 108 might not be met. Horizontal adjustment might negatively impact intended roadway illumination and glare protection, increasing the risk of a crash.

Description of the cause:

Due to a deviation in the vehicle production process, the retaining caps covering the horizontal aiming screws of the headlamps might not have been installed.

In March 2023, MBAG found that the retaining caps to prevent horizontal adjustment of the headlamps might not have been installed according to specifications on early production vehicles. A rework within the plant was initiated and it was believed that all potentially impacted vehicles were captured during the rework.

In April 2025, an investigation was conducted with regard to headlamp replacements or repairs on the same vehicle population. During that investigation, it was found that some vehicles may have left the plant without having been subject to the initial factory rework.

On May 23, 2025, MBAG concluded that a potential noncompliance with FMVSS 108 cannot be ruled out. A decision was made to conduct a recall to install the retaining caps on the headlamps of the potentially affected vehicles.

MBAG can confirm there are no warranty claims, field or service reports relating to this noncompliance.

An authorized Mercedes-Benz dealer will check the headlamps on the potentially affected vehicles and retrofit the retaining caps if necessary.
Pursuant to 49 C.F.R. § 577.11(e), MBUSA does not plan to provide notice about pre-notice reimbursement to owners since none of the involved vehicles would have been previously subject to the condition described and all remain covered under the new vehicle warranty.
How remedy component differs from recalled component:
