Descriptive Information:

Some 2024-2025 MY Dodge Charger battery electric vehicles may have been built with amplifiers with an incomplete software upload, which may prevent the emission of exterior sound.

The suspect period began on April 30, 2024, when the first 2024 MY vehicle was produced, and ended on March 18, 2025, when the last suspect vehicle was produced. Engineering release and vehicle manufacturing records were used to determine the suspect population.

Similar vehicles not included in the recall were built after the suspect period.

Defect / Noncompliance Description

Description of the defect or noncompliance:

Federal Motor Vehicle Safety Standard ("FMVSS") No. 571.141 requires that electric vehicles emit a sound level and sound characteristics that meet the requirements of the S5.1 "2-band alert" and S5.4 "Relative volume change." Suspect vehicles may not emit the required sound.

Chronology

- On April 17, 2025, the FCA US LLC ("FCA US") Technical Safety and Regulatory Compliance ("TSRC") organization opened an investigation into some 2024-2025 MY Dodge Charger vehicles which may not emit exterior sound.
- From April 17, 2025, through May 13, 2025, FCA US TSRC met with FCA US Engineering and the Supplier to understand all potential failure modes of the issue, and reviewed warranty data, field records, and customer assistance records to determine field occurrences.
- On May 14, 2025, FCA US TSRC organization recognized that a vehicle build issue existed on certain vehicles related to a no EV exterior sound condition potentially resulting in a noncompliance with FMVSS No. 141.
