The recall population is defined by vehicles built from 02/11/2020 through 08/28/2023 assembled with electrical motor steering system N99462 supplied by Allient without check valve.

Defect / Noncompliance Description

Description of the defect or noncompliance:

The subject vehicles have been manufactured with an electric power steering system. Under certain conditions, while the vehicle is stationary (in D, P, or R mode) and with front wheels against a curb and a steering maneuver being performed, increasing the load against the motor, an overcurrent may occur causing the electric steering motor to shut down and allow the hydraulic pressure to return from the pump to the steering wheel.

Description of the safety risk, including crash, fire, death, injury:

This situation can generate a kickback to the steering wheel. A steering wheel kickback may increase

April 29, 2025: Nova Bus was informed about two potential injuries caused by the issue.

April 30, 2025: The issue was raised to the safety forum as a potential risk for evaluation.

May 07, 2025: Nova Bus received a letter of concern from the customer mentioning the issue.

May 07, 2025: The supplier started a preliminary analysis.

May 15, 2025: Nova Bus opens a formal potential safety related issue investigation.

May 21, 2025: Nova Bus elaborate a test plan to evaluate all conditions of issue occurrence.

May 27, 2025: Nova Bus complete the test report.

July 10, 2025: Product Safety Evaluation Committee evaluates and raises to Product Safety Committee.

July 15, 2025: Product Safety Committee determination of product defect.

July 22, 2025: Nova Bus files 573 with NHTSA that a voluntary recall will be released to address the safety-related defect.

Remedy Type:
Consumer Advisories: Do Not Drive Park Outside
Description of remedy program:
Remedy program will be to install a check valve at the pump inlet. All costs associated with this corrective measure will be covered by Nova Bus. Pre-notification remedies will be addressed using the Nova Bus general reimbursement plan on file with NHTSA.
How remedy component differs from recalled component:
The check valve will prevent the pressure return to the steering system.
Identify how/when recall condition was corrected in production:
A Delivery Stop was launched in July 17, 2025. The vehicles delivered after this date will have the correct electrical motor steering system.
