The subject awning may deploy without input from the owner and/or occupant.

Description of the safety risk, including crash, fire, death, injury:

If the subject Fiamma awning deploys unexpectedly during operation without input from a vehicle occupant, the deployed awning could distract the driver or temporarily make the vehicle more difficult to operate. An awning that deploys without input from a vehicle occupant could strike another road user or otherwise create a road hazard. These events could increase the risk of crash or injury.

Description of the cause:

If the microswitch does not disengage the motors, the motors will over power the winch causing damage to the gears within the winch.

Chronology

- January February 2025: Grech RV seeks input from Fiamma concerning instances of inadvertent awning deployment. Fiamma denied the existence of a manufacturing defect.
- June 24, 2025: Grech RV received notification from the awning supplier, Fiamma, Inc., of an incident of unintended awning deployment. Grech reviews the circumstances of this incident and undertakes an investigation into the subject awning.
- July 1, 2025: While Grech RV is conducting its review of the incident and company data, Grech receives an email inquiry from NHTSA regarding VOQ #11668764.
- July 17, 2025: Grech RV provides information to NHTSA in response to its email inquiry regarding VOQ #11668764.
- July 23, 2025: Grech RV provides additional information to NHTSA stemming from its email inquiry.

As of the date of this submission, following a review of available records, Grech RV has received 19 warranty claims involving alleged inadvertent awning deployment, the first of which was received in September 2023.
