Descriptive Information:

The recalled part was introduced into production on 01/15/2019 and was taken out of production on 12/14/2022. Affected vehicles are equipped with a rearview camera only; vehicles equipped with 360-degree camera systems are not affected.

These vehicles are not produced in VIN order. Defect / Noncompliance Description

Description of the defect or noncompliance:

Corrosion on the rearview camera harness and connector can cause the rearview camera to have intermittent rearview video image, no rearview video image, or blurry, foggy, or hazy image quality when the vehicle is in reverse gear.

Description of the safety risk, including crash, fire, death, injury:

A rearview camera that intermittently displays a blank or distorted image may reduce the driver's view of what is behind the vehicle, increasing the risk of a crash.

Description of the cause:

Water intrusion into the camera connector causes corrosion due to an uninsulated "drain" (ground) wire.

Chronology

On **June 12, 2025,** an issue pertaining to an uninsulated rearview camera drain wire was brought to Ford's Critical Concern Review Group for review. Ford identified this concern while investigating root cause for Safety Recall 25V-048 (25S05) related to rearview camera concerns on 2020-2022 Lincoln Corsair.

From June to July 2025, CCRG reviewed warranty claim data, Vehicle Owner Questionnaires (VOQs), and completed a design review of the rearview camera system. CCRG reviewed this concern across vehicle lines and determined that this concern only affects MY 2020-2022 Corsair vehicles equipped with an analog rearview camera as Corsair vehicles with a digital camera utilize a different wire harness design that does not have an uninsulated ground wire. CCRG did not identify any other Ford or Lincoln vehicles with this concern.

In July 2025, Ford conducted vacuum testing and then confirmed that the bare wire is a causal factor to the rearview camera image quality issues described below.

Ford is aware of 316 warranty claims related to camera wiring issues, 267 specifically calling out corrosion or water intrusion. The first claim was received March 26, 2020.

On **August 1**, **2025**, Ford's Field Review Committee reviewed the concern and approved a field action.

Ford is not aware of any reports of accident or injury related to this condition.

Remedy Type: Replace
Consumer Advisories: Do Not Drive Park Outside
Description of remedy program:
Owners will be notified by mail and instructed to take their vehicle to a Ford or Lincoln dealer to have the rearview camera harness and rearview camera replaced. There will be no charge for this service.
How remedy component differs from recalled component:
The remedy rearview camera harness will contain an insulated drain wire which will adequately protect the rearview camera connector from water intrusion.

Not required per 49 Part 573.

Notification to dealers is expected to occur on August 8, 2025. Mailing of interim owner notification letters is expected to begin August 18, 2025 and is expected to be completed by August 22, 2025.
