Mercedes-Benz MY24 GLA 250 8 vehicles. The recall population was determined through production records. Vehicles outside the recall population have headlamps installed with the required optical reference marking point.

Defect / Noncompliance Description

Description of the defect or noncompliance:

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has determined that on certain Model Year "MY" 2024 GLA (247 platform) vehicles, the front headlights might be missing the required optical reference marking point.

FMVSS1: 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS2:

Description of the safety risk, including crash, fire, death, injury:

The affected vehicles left the plant with the correct headlight adjustment since the plant does not use this marking point. However, headlight adjustment using the wall projection method in an independent workshop might not be performed according to the requirements specified in FMVSS 108.

As a consequence, the headlights might not be aimed correctly, which might lead to glare for oncoming traffic, increasing the risk of a crash.

Description of the cause:

Due to a deviation in the production process of a supplier, a certain batch of headlights might not meet specifications.

Identification of any warning that can occur:

The driver will not receive a warning due to the nature of the failure mechanism.

Chronology

In January 2024, Mercedes-Benz AG discovered that the front headlights might not have been manufactured according to specifications by the supplier, and that the optical axis marking point was missing.

Headlight replacement within the factory was initiated and it was believed that all potentially affected vehicles were captured before delivery.

In end of May 2025, an investigation regarding headlight replacement or repairs on the same vehicle population was conducted. During this investigation, it was found that some vehicles might have left the factory without undergoing the original factory rework.

MBAG started an analysis regarding the potential consequences of a missing marking point. In this context, it was especially examined whether a correct headlight setting can also be achieved without a marking point indicating the optical axis. In July 2025, it was concluded that a correct headlight setting is always ensured since (i) the headlights setting during vehicle production uses the alternative trade mark marking on the headlights, which is present and not affected by the supplier issue and (ii) the vehicle headlight setting in Mercedes-Benz workshops uses a headlight aiming device and does not rely on the optical axis marking point. Therefore, vehicle headlights are correctly aimed when vehicles are produced, and correctly aimed during any repair procedure at a Mercedes-Benz workshop. However, correct adjustment cannot be guaranteed at an independent workshop that might not use a headlight aiming device.

In parallel, MBAG investigated relevant worldwide regulations.

On August 1, 2025 MBAG determined that a potential non-compliance with FMVSS 108 cannot be ruled out and decided to conduct a recall.
