On August 18, 2025, during a routine inspection at the manufacturing plant it was discovered that the breakaway switch was wired to the incorrect side of the battery disconnect switch. On the same day Forest River's Office of Corporate Compliance (OCC) opened a research item

On August 22, 2025, Forest River's Corporate Recall Committee voted this to recall. All vehicles are currently located at Dealers. No vehicles are sold retail. A stop sale notice is being issued.

#### Description of remedy program:

Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy to wire the breakaway switch to the correct side of the battery disconnect.

#### How remedy component differs from recalled component:

Affected Component – 12V Wiring Replacement Component – 12V Wiring

The breakaway switch will now be wired to the correct side of the battery disconnect.

#### Identify how/when recall condition was corrected in production:

During the week of August 18, when the concern was discovered in the final inspection area of the plant, all other units were checked and corrected, by moving the breakaway switch power to the constant power side of the battery disconnect. It was discovered at that time 7 units had shipped that may be wired incorrectly.
